Schedule A to the NATIONAL SERVICE AND MAINTENANCE AGREEMENT

Jurisdiction: Local 525, Las Vegas, Nevada

In accordance with Article XX, Paragraph 72, this schedule is entered into on behalf of the signatory Contractors to the current National Service and Maintenance Agreement dated August 1, 2015.

SPECIAL CONDITIONS

SHOP STEWARDS: If multiple issues arise for a specific Employer and the Employer has been made aware of the issues without action, the union may deem it necessary to appoint a steward from the Employer's current work force. The Employer will participate in the selection of the steward. Stewards shall be qualified workmen performing work of their craft and shall exercise no supervisory function. There shall be no nonworking shop stewards.

ARTICLE XII Wages, Benefits, and Hours of Work

Paragraph 33: modified to read - Eight (8) consecutive hours per day shall constitute a standard work day with an established start time which can vary by Employee. Forty (40) hours per week, five (5) consecutive days, Monday through Saturday, shall constitute a week's work or as mutually agreed to by the Employer and the local union. By mutual agreement between the Employer and the Local Union, the standard work week can be establish to consist of four (4) consecutive ten (10) hour days.

Paragraph 33 A — It is in the best interest of the industry that no moonlighting be permitted, unless prior authorization was given by the employer.

Paragraph 40 - Servicemen - Rate of pay shall be not less than 50% or more than 80% of the Service Journeyman wage rate. The employer, with mutual agreement of the Local Union, will establish wages for each Serviceman based on experience and training.

Paragraph 42 - Service Tradesman - Rate of pay shall be 40% of the Service Journeyman rate.

Paragraph 45 – Last sentence should read, "...paid only to the Trust Funds (not trustees)."

Paragraph 47 – Modified to include: Compensation for on-call duty to be \$100 net minimum per week. All Journeymen and Servicemen to be included in the rotational assignment of on-call duty by the Employer. An Apprentice may perform on-call duty with the approval of the union and the Employer. 4th and 5th year Apprentices shall be compensated at the rate for their next period of apprenticeship for hours worked while on call.
