### The Latest News

- **U.S. COVID-19 cases** exceed 1,373,172 and 82,161 U.S. deaths. (Source: CDC) (**Updated 5/13/20**)
- **U.S. stock market:** Tuesday ended with losses across the major U.S. benchmarks, with the Dow and S&P down slightly at 32 and 15 points, respectively, while the Nasdaq posted a steeper decline at 122 points. (**New**)
- Yesterday, the House Democrats introduced a **comprehensive \$3 trillion aid package, the HEROES Act** (H.R. 6800), and scheduled a floor vote for Friday. The stimulus package includes additional funds for state, local, and tribal governments, an expanded tax credit for employers for employee retention, a 2-year suspension of the cap on state and local taxes, a second round of economic impact payments for individuals, an extension of unemployment benefits through

January 2021, aid for public transportation systems, and a proposal for essential worker ‘hazard’ pay. The 1,815 page bill may move quickly through the House and certainly starts the official negotiations for bill 4.0, but the Senate is not expected to act with the same pace on an alternative proposal. Senate Majority Leader Mitch McConnell called the House bill “aspirational” signaling that closing the distance between the two bodies on the scope of 4.0 will take some time. (**New**)

## COVID-19 Federal Legislation

- **Bill 4.0:** On May 12, the House Democrats introduced the Health and Economic Recovery Omnibus Emergency Solutions (HEROES) Act, a large aid package scheduled to move quickly to a Friday House vote. If the House completes this short timeline to passage, the Senate deliberations are expected to move well into June before House-Senate negotiations on consensus bill is likely. ## Department of Justice/Federal Trade Commission/Litigation

### Consumer Protection/Anti-fraud

- On May 8, the FTC [announced](#) it is soliciting comments on whether it should make changes to its 2009 “**Health Breach Notification Rule**,” which mandates the disclosure of data breaches by firms that handle personal health data but who are not covered by the Health Insurance Portability and Accountability Act, or HIPAA, which has its own breach notification rules. The rule has not been invoked in the past decade, but as consumers are increasingly turning to telehealth, more companies may be covered by this rule. FTC seeks comments on the rule's definition and whether companies should be required to report data breaches sooner as well as whether and how the rule should address any developments in health care products or services related to COVID-19. These comments will be accepted for 90 days after the rule review notice is published in the Federal Register. (**New**)
- The Federal Trade Commission (FTC) [sent](#) 45 letters warning marketers nationwide to **stop making unsubstantiated claims that their products** and therapies can treat or prevent COVID-19. This fourth round of letters targeted “treatments” including Chinese herbal medications, music therapy, homeopathic treatments, and even shields claimed to boost the immune system

by protecting the wearer from electromagnetic field. There is currently no scientific evidence that these or any services can treat or cure COVID-19. The letters warn that if marketers refuse to stop making false claims, the FTC may seek an injunction and an order requiring money be refunded to consumers. (5/7/20)

## Litigation Issues

- The Department of Justice [announced](#) the **first enforcement action regarding alleged PPP fraud**. The DOJ alleged that two defendants falsely claimed to have dozens of employees at several locations to get more than \$500,000 in forgivable loans. (5/5/20)

While no sector has been immune from significant job losses, the health care sector impact is especially complex since hospitals and other providers were required to ramp up emergency, ICU, and testing capabilities in preparation for the surge in coronavirus cases which was predicted, but elective procedures were suspended resulting in layoffs in nearly all types of outpatient and clinic settings.

## Small Business Administration

- **Small Business Administration (SBA)** – In response to the **CARES Act** requirements, the SBA formally [launched](#) its **Paycheck Protection Program (PPP)** for small businesses. (4/3/20)
  - The SBA [updated](#) its statistics on Round 2 loans showing that it had made 2.65 million loans totaling \$191.4 billion. (5/12/20) (**New**). The SBA previously released Round 2 [data of the PPP](#). (5/8/20)
  - The SBA released its latest PPP [data](#) that the agency had processed 2.5 million applications from 5,425 lenders for loans totaling \$185.4 billion. The average loan size is a little greater than \$74,000. The posted data also shows that 53% of the loan amount

- has come from banks with more than \$50 billion in assets, 15% from mid-size banks, and 32% from lenders with less than \$10 billion in assets. (5/7/20)
- The SBA and Treasury **updated their FAQs on the Paycheck Protection Program**. The [FAQs](#) clarify that **employers will not be penalized if they are unable to rehire a worker** despite good faith efforts. (Updated 5/6/20)
  - The FAQs also **extend the safe harbor to repay PPP loans** until May 14 and confirms that **foreign affiliate employees** must be counted for size purposes.

Ahead of a Monday call with U.S. Trade Representative Robert Lighthizer, European Trade Commissioner Phil Hogan outlined a trans-Atlantic trade agenda in a letter to his U.S. counterpart that included Boeing and Airbus subsidies, steel and aluminum tariffs and duties on other products, expedited regulatory approvals and the establishment of “joint reserves” of medical supplies, according to a report in the Financial Times. According to Hogan, who spoke during a [webinar](#) run by the Dublin-based Institute of International and European Affairs, he wrote to Lighthizer to “identify some leading principles” for the U.S. and EU in working together to tackle areas that have been affected by trade policy decisions amid the pandemic. (**New**)

- **Phase-one deal in flux as China reportedly debates whether to walk away.** After months of touting the outcomes of the U.S.-China phase-one trade agreement, Trump administration officials have gone mum on whether they think the deal should remain in place -- while China reportedly is considering whether it should walk away. "In the past, some trade negotiators believed that it would be worthwhile to make certain compromise to reach a partial truce in the 22-month trade war and ease escalating tensions," the Global Times, a tabloid run by the Chinese Communist Party, said in [an article](#) on Monday. "However, given U.S. President Donald Trump's hyping an anti-China conspiracy that aims to cover up his mishandling of the COVID-19 pandemic, advisors close to the trade talks have suggested Chinese officials rekindling the possibility of invalidating the trade pact and negotiating a new one to tilt the scales more to the Chinese side, sources close the matter told the Global Times." **(New)**
- **Grassley: Mexico's industrial approach to pandemic a "serious problem."** Mexico's decision to shut down some industrial sectors by deeming them non-essential amid the coronavirus outbreak is a "serious problem," Senate Finance Committee Chairman Chuck Grassley (R-IA) said on Tuesday, citing impacts on North American supply chains. Grassley, in a conference call with reporters, said he was "very definitely" worried about Mexico's definition of essential services and the impact on key supply chains. "I've been hearing from Iowans about the issue and ... the point in which they [Mexico] are going to say who can work and not work. Yes, we see that as a serious problem," Grassley said.

Ted Budd (R-NC) indicating that "Treasury is actively monitoring the various proposals being discussed in Congress, state legislatures, and the private sector related to insurance and business interruption coverage." He went on to note that while insurers "should pay valid claims," the various legislative proposals "could fundamentally conflict with the contractual nature of insurance obligations and could introduce stability risks to the industry." **(New)**
- On April 24, the Rutgers Center for Risk and Responsibility and the National Council of Insurance Legislators (NCOIL) sponsored a webinar attended by hundreds of legislators, government officials, industry professionals and others to discuss state legislative proposals that would **retroactively require insurers to provide coverage** for business income losses caused by COVID-19. NCOIL President [reportedly](#) "began by expressing NCOIL's opposition to retroactive legislation at the state level." A [recording](#) of the webinar is available online.
- The National Association of Insurance Commissioners has issued a [Business Interruption COVID-19 Data Call Letter](#) to **property and casualty insurers indicating that state insurance regulators**

in 50 states, the District of Columbia, and the U.S. territories “have agreed to participate in a data call to collect data related to business interruption insurance and COVID-19.” Insurers are “requested to complete both parts of the COVID-19 business interruption data call” and to submit a “Premiums Data Template” by May 22, and a “Claims Data Template” by June 15, with mid-monthly update filings thereafter.

- The pace of new business income coverage claims flooding state and federal courts nationwide has not slowed over the last few weeks. In addition to new case filings, a group of insurance industry trade groups led by the American Property Casualty Insurance Association has filed an [Amici Curiae Brief](#) in *Tambellini v. Erie Insurance Exchange*, urging the Pennsylvania Supreme Court to deny Plaintiff’s Emergency Application for Extraordinary Relief, which seeks to bypass the ordinary course trial court procedures and catapult Plaintiff’s claims straight to the Pennsylvania Supreme Court under the court’s infrequently-used King’s Bench Powers.
