## The Latest News

- U.S. COVID-19 cases exceed 1,655,625 and 97,212 U.S. deaths. (Source: CDC) (Updated 5/25/20)
- **U.S. stock market**: On Friday the U.S. benchmarks posted mixed results, with the Dow dropping slightly at 8 points, and the S&P 500 and Nasdaq posting small gains at 6 and 39 points, respectively. (New)
- On Sunday, President Trump <u>released an order</u> restricting nearly all travel from Brazil for non-U.S. citizens if they were in the country during the prior 14-day period. Green card holders, close relatives of U.S. citizens, and flight crew members are exempt. The order notes that the Centers for Disease Control and Prevention has determined that Brazil is experiencing "widespread, ongoing person-to-person transmission" of COVID-19. (New)
- Late Friday, the Small Business Administration, jointly with the Department of Treasury, <u>released</u>
   <u>the interim final rule</u> for the PPP loan forgiveness process. The SBA also <u>released the interim</u>
   <u>final rule</u> the PPP loan review procedures and borrowing responsibilities. (New)

- The Department of Health and Human Services (HHS) <u>released a report</u> to Congress on its COVID-19 Strategic Testing Plan on Sunday, as required by the Paycheck Protection Program and Health Care Enhancement Act. The report outlines 3 primary purposes for active testing: diagnostic testing, testing for contact tracing, and surveillance testing. The report was immediately <u>criticized</u> by congressional Democratic leaders as being light on data and results. (New)
- On Friday, the HHS <u>released a statement</u> <u>extending the Provider Relief Fund attestation</u> deadline for an additional 45 days. This allows providers 90 days from the date they received a payment to accept the Terms and Conditions or return the funds. (New)

## **COVID-19 Federal & State Legislation**

- Bill 4.0: Congress is not expected to move forward during this short work week on the 4.0 emergency stimulus bill, but both bodies may consider legislation to provide more flexibility for small businesses through the Paycheck Protection Program (PPP). In the Senate, separate bills were introduced last week by Senators Marco Rubio (R-FL) and Ben Carper (D-MD), and by Senators Angus King (I-ME) and Steve Daines (R-MT), to extend the time businesses have to use PPP funds. The House is scheduled to vote under suspension of the rules on Wednesday on a bill sponsored by Representatives Dean Phillips (D-MN), which is very similar to bill (HR 6886) sponsored by Rep. Chip Roy (R-TX) to enhance the provisions for PPP loan forgiveness and to defer payroll taxes. These House bills are nearly identical to the bill sponsored by Senators King and Daines.

- The **Department of Justice** <u>announced</u> that it charged an individual with **fraudulently obtaining \$20 million in PPP loans for two companies that had no employees**. The defendant allegedly claimed that his companies were helping New York State obtain COVID-19 test kits and personal protective equipment. (5/21/20)
  - DOJ also <u>charged</u> a defendant with fraudulently seeking \$5 million in PPP loans from two different banks. (5/19/20)
- The Federal Trade Commission (FTC) sent warning letters to 50 more marketers nationwide to stop making unsubstantiated claims that their products and therapies can treat or prevent COVID-19. (5/21/20)
  - o The FTC and SBA sent warning letters to two companies that may be misleading small businesses seeking SBA loans as a result of COVID-19. One of the companies has claims like "Your Paycheck Protection Program Loan starts here!" while the other claims it is an authorized SBA loan packager for PPP and advertised its services for a \$495 fee, despite the SBA prohibiting lead generators or other agents from charging fees to PPP loan applicants. The FTC's letters warn the companies to take immediate action to ensure all deceptive claims are removed and to remediate any harm to small business consumers as a result of the claims. The recipient companies must also notify the FTC within 48 hours what specific actions they took to address the agency's concerns. (5/18/20)
  - The FTC has <u>advised</u> nursing homes and assisted living facilities that they cannot take residents' stimulus payments simply because the resident is on Medicaid. The Iowa Attorney General's Office and other State AGs have received reports that these facilities have been requiring residents to sign over their stimulus payments against the CARES Act directives. According to the CARES Act, those economic impact payments are considered tax credits which do not constitute "resources" for federal benefits programs, including Medicaid. (5/15/20)
- The Department of Justice Antitrust Division issued its third expedited business review letter (BRL) related to COVID-19 collaborations, this time in connection with collaboration by pork producers and processors. COVID-19 outbreaks forced many meat plants to close, leading to a reduction in processing capacity. As a result, some hogs are now unmarketable because they have grown too large to fit on processors' production line equipment. DOJ approved the National Pork Producers Council's proposal to allow its members to coordinate with each other and the USDA and share information to address these supply chain issues. (5/15/20)

The Department of Labor (DOL) announced publication of a <u>final rule</u> that expands the ability of private sector employers to communicate retirement plan information online or by email.

- The Department of Labor <u>announced</u> a final rule that allows employers to pay **bonuses** or other incentive-based pay to salaried, nonexempt employees whose hours vary from week to week. The final rule clarifies that payments in addition to the fixed salary are compatible with the use of the fluctuating work week method under the Fair Labor Standards Act (FLSA). (5/20/20)
- The **DOL** <u>updated</u> its resources for employers, employees, and states to prevent unemployment insurance fraud. (5/19/20)
- The Occupational Safety and Health Administration (OSHA) <u>announced</u> that it was revising two
  enforcement policies regarding COVID-19. First, OSHA updated its <u>interim enforcement response</u>
  <u>plan</u> for COVID-19 to increase in-person inspections at all types of workplaces. Second, OSHA
  updated its <u>enforcement guidance</u> requiring employers to record work-related coronavirus

- **OSHA** <u>announced</u> that it was making \$11.5 million available in grants to non-profits to support training on workplace safety and health hazards. (5/19/20)

This amendment should increase availability of food-contact surface sanitizers, benefiting facilities processing low moisture products like grains, cereal, flour, and industrial baked goods, which have been experiencing sanitizer shortages. - On Sunday, President Trump <u>released an order</u> restricting nearly all travel from Brazil for non-U.S. citizens if they were in the country during the prior 14-day period. Green card holders, close relatives of U.S. citizens, and flight crew members are exempt. (5/24/20) (New)
- The **U.S.-Canada Border To Remain Closed Through June 21.** Canadian Prime Minister Justin Trudeau during his daily press conference commented that "[i]t was the right thing to further extend by 30 days our closure of the Canada, U.S. border to travelers other than essential services and goods, but we will continue to watch carefully what's happening elsewhere in the world and around us as we make decisions on next steps."
- USDA APHIS Allows Electronic Copies of Veterinary Certificates and Phytosanitary Certificates
   Due to COVID-19 through July 18. The U.S. Department of Agriculture's Animal and Plant Health
   Inspection Service has <u>extended</u> the interim guidance for the electronic submission of veterinary
   health certificates, phytosanitary certificates, and PPQ 203 forms for shipment clearance due to
   COVID-19 pandemic. The guidance is now effective through July 18, 2020.

- On May 21, the National Association of Mutual Insurance Companies, jointly with other
  insurance industry trade associations, <u>announced</u> a proposal for a new federal program to
  assist businesses in the event of a future pandemic risk. The Business Continuity Protection
  Program would "provide revenue replacement assistance . . . following a presidential viral
  emergency declaration." The program would be administered by the Federal Emergency
  Management Agency with assistance from private contractors. (New)
- On May 19, the Organized Dentistry Coalition (the "ODC") sent a <u>letter</u> to Congress recommending that it support <u>HR 6494</u>, the Business Interruption Insurance Coverage Act, which if passed would require insurers to "make[] available business interruption insurance coverage" for COVID-19 related losses for an increased premium. The ODC noted that many dental practices have "learned that their policies do not cover government-ordered business shutdowns caused by a national emergency" and that the lack of coverage has had a "substantial negative impact" on dental practice owners. However, the ODC acknowledged that "abrogating or re-writing contracts at this time could potentially have a deleterious impact on the property and casualty insurance industry, as current policy premiums did not account for the risk associated with these pandemic-related losses when they were calculated." (New)
- On May 15, the Louisiana Senate proposed an <u>Amended Senate Bill 477</u>. The original bill would have retroactively required insurers to provide business interruption coverage for COVID-19 related business income losses, regardless of policy language. The May 15 amended bill nixes the controversial retroactive requirements and instead requires that all policies issued after August 1, 2020 "include a notice of all exclusions on a form prescribed by the commissioner of insurance" which shall "be conclusively presumed to become a part of the policy of contract when issued and delivered." (New)

- The pace of new business income coverage claims flooding state and federal courts nationwide has not slowed over the last few weeks. Notable filings and orders include:
  - On May 22, Healthnow Medical Center Inc. filed suit in California state court against its insurer, State Farm General Insurance Company, alleging claims for breach of contract, bad faith, and unjust enrichment. Plaintiff alleges that State Farm wrongfully denied Plaintiff's claim for lost business income arising out of the COVID-19 related governmental orders and seeks punitive damages. The case is Healthnow Med. Ctr. Ins. v. State Farm General Ins. Co., No. T20-1121 (Santa Clara Cnty. Sup. Ct., Cal.). (New)
  - On May 21, Gervasi 1700 LLC brought suit in Ohio state court against National Trust Insurance Company, Franchise Insurance Agency Inc. dba Leavitt Group Midwest, and Bradley W. Stammler alleging that defendants Stammler and Leavitt group failed to disclose that the policy they procured for Plaintiff from defendant National Trust contained a virus and bacteria exclusion. Plaintiff alleges claims for breach of contract, bad faith and negligence. The case is Gervasi 1700 LLC v. National Trust Ins. Co., et al., No. 2020CV00818 (Stark Cnty. Ct. of C.P., Ohio). (New)
